This plan is designed to fit the financial situations of a greater number of individuals and families by using your income level to determine your personal Y membership rate. The plan provides an affordable monthly payment for families with annual incomes of \$50,000 and under and adults/seniors with incomes of \$35,000 and under. It is easy to determine your monthly or annual rate by asking our Front Desk Staff to give you an estimated rate or use the calculator found on our Web Page at www.pikecountnymca.org. Go to the Membership tab, and select Personal Pricing, then follow the simple steps. You will also find an application on the web or you may pick up one at the Front Desk. Next, submit the completed application along with all requested forms for income verification. Then follow the simple directions found in the letter to purchase your membership.
